Breezmore Guarantee of Health

Breezmore Kennels sells their puppies under the National Stock Dog Registry (N.S.D.R) with a limited registration. Puppies are sold with companionship as the buyer's first reason for buying this puppy. As per a spay-neuter agreement, you will receive N.S.D.R registration papers with proof of spay/neuter by eight (8) months of age. Breezmore Kennels is a registered kennel name; the first part of the registered name of the puppy will be "Breezmore's."

Breezmore Kennels hereby warranties to the purchaser that to the best of their knowledge and belief, said dog is in sound body and health and free from communicable disease as far as appears to the eye. If any defect was found it will be disclosed at the bottom of this form.

We agree that in the event of death or sickness of said puppy within one week of date of purchase, we will either replace or refund the total purchase price of said dog. Provided that: the purchaser has dog examined by a licensed veterinarian within twenty-four (24) hours of suspected sickness, or within one (1) week of date of purchase, has notified seller if puppy is anything but healthy and has returned puppy to seller, within twenty-four (24) hours of diagnose, for treatment by our veterinarian. A letter from the purchasers licensed veterinarian stating that puppy was not healthy and that condition was present at time of sale is required.

If said puppy or dog dies within one year of age due to a congenital defect (condition present at birth) replacement of like sex, color and breed will be made as soon as available, as long as a letter from a licensed veterinarian is provided stating death is due to a congenital defect from birth. We give no guarantee as to size, markings, barking, activity level or anything else that does not affect the lifespan of the dog.

If this puppy develops severe hip dysplasia, that requires surgery or euthanasia before the age of eighteen (18) months, we will replace the puppy with another from like breed, sex and color as soon as available. A copy of this agreement, an Orthopedic Foundation of Animals (O.F.A) official rating of severe, and a letter from buyer's veterinarian stating that the condition was a result of breeding and that there has been no **trauma, injuries from jumping, neglect, and/or other environmental conditions** must be presented. Also the return of first puppy, unless other arrangements are made, in order to receive replacement. There will be no cash refunds or any payment of surgery or vet costs the buyer decides to incur.

This agreement shall be null and void if it appears that the death or illness is do to neglect of care of buyer or if the puppy began agility trials before the age of one (1) year.

If at anytime the buyer is unable to keep the said puppy please contact us. We will be happy to help you place your dog in a good home or will take him/her back here in our home. No refund of money or replacement puppy will be offered under these circumstances. At no time should you take your puppy/dog to a shelter/pound. **Breeder strongly encourages buyer to attend puppy obedience classes with puppy to help provide proper socialization.**
